We acknowledge receipt of your letter dated 25/07/2016, requesting NIRP to review the decision of COFFEE EXPORTERS & PROCESSORS ASSOCIATION OF RWANDA (CEPAR) related to the supply of 3,500MT of coffee fertilizer NPK 22-6-12+3S to CEPAR.


In the Article 1, 25^o of Law N°05/2013 of 13/02/2013 modifying and completing the Law N° 12/2007 of 27/03/2007 on Public Procurement, a Procuring Entity is defined as:

"any organ of Central Government authority, Local Government authority, public institution, commission, Government project, parastatal, agency or any government entity charged by the chief budget manager to manage public funds engaged in a procurement process and entering in contract with the successful bidder".


NIRP members noted that CEPAR is an Association, thus not classified as a Procuring Entity as stipulated in the above mentioned provision of the law. Therefore, National Independent Review Panel does not have the mandate to review the appeal.
