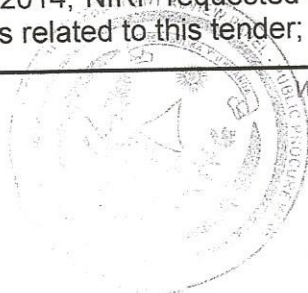
2. SUMMARY OF THE COMPLAINT

IMANZI LTD is contesting the decision taken by MHC cancelling the tender while the step of the procurement process was at the negotiation contract.

3. SUMMARY OF FACTS

- On 24/10/2013, MHC advertised the tender;
- On 16/12/2013, Technical proposal were opened;
- On 15/01/2014, IMANZI LTD received the provisional notification letter;
- On 03 and 10/02/2014, MHC invited IMANZI LTD for contract negotiation;
- On 06/03/2014, MHC wrote a letter to IMANZI LTD informing the cancellation of the tender;
- On 11/03/2014, NIRP received the appeal from IMANZI LTD;
- On 17/03/2014, NIRP requested MHC to suspend procurement process and submit all documents related to this tender;
