1. INTRODUCTION

Pursuant to the article 70 of the Law N°12/2007 of 27/03/2007 on Public Procurement as modified and complemented to date, on 21st April 2014, members of the National Independent Review Panel (NIRP) analysed the appeal introduced by LAGENIETRAS LTD against the decision for the tender award.

2. SUMMARY OF THE COMPLAINT

LAGENIETRAS LTD is contesting the KHIBD LTD's decision to disqualify its bid on the argument that the provisional successful bidder does neither present the "Attestation de créance" nor "Attestation de non créance" issued by Rwanda Revenue Authority.

3. DECISIONS BY THE PANEL MEMBERS
