SUBJECT: Response to your letter N° 827/036 of 11/12/2013

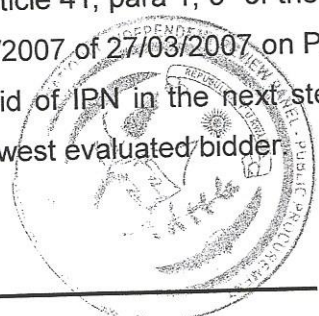
Reference is made to your above letter transmitting the feedback on the decision of NIRP of 07/11/2013 and requesting NIRP to be specific on recommendation in article 41 of the Law N°05/2013 of 13/02/2013 modifying and completing the Law N° 12/2007 of 27/03/2007 on Public Procurement;

Concerning your feedback on IPN's (complainant) certificate of good completion which you considered as related to supply of office stationery, NIRP noted that the complainant provided you with further documents indicating that the certificate was related to printing services.

NIRP considered those documents to be enough evidence that the above certificate was related to printing services. Consequently, the NIRP's decision N° 077/2013/NIRP was not based on documents submitted later, rather to the original documents that were in the bid documents.

Based on the above, therefore there is no extra information provided for a possible reconsideration of the prior decision made.

Concerning your request, pursuant to article 71, para 1, 5° of the Law N°12/2007 of 27/03/2007 on Public Procurement as modified and completed to date, or to article 41, para 1, 5° of the Law N°05/2013 of 13/02/2013 modifying and completing the Law N° 12/2007 of 27/03/2007 on Public Procurement, NIRP order you to re-evaluate and consider the bid of IPN in the next step of technical evaluation and award the tender to the responsive and lowest evaluated bidder.
